

Research for Patient Benefit (RfPB) Programme

What is it

- Funds applied research projects in health services and social care.
- Main purpose to realise, through evidence, the huge potential for improving, expanding and strengthening the way that health care is delivered for patients, the public and the NHS.
- 'RfPB particularly welcomes proposals that have benefited from interaction with patients and the public, which relate to patient and service user experience and/or have been drawn up in association with a relevant group of service users'.
- Does not specify topics for research.
- Open to researchers in the NHS.
- Up to £250k for 36 months.
- Supports pilot studies.

What they are looking for

 Research related to day-to-day practice in areas identified and developed by health service staff – often in partnership with service users.

- A sound and appropriate research design.
- A strong likelihood that tangible benefits for NHS patients and other users of health and social care services will be realisable in the short to medium term (within 3-5 years).
- A team with the right mix of skills and experience for the research question.
- Evidence of relevance for the public or patient community.

How to apply and timelines

- 1st need to complete registration of intention to submit (ROI).
- 3 competitions per year
- Competition 13
- Registration of intention to submit 13 August 2010
- Submission deadline 24 September 2010
- Submission outcome March 2011
- Notified of outcome of application within 24 weeks of the deadline for submission date

What is it

3 key aims:

Impact: to increase knowledge & understanding of the impact of

public involvement in research

Evaluation: to identify methods of evaluating public involvement in

research

Implementation: to identify effective ways of involving the public in

research

- Including NHS, public health & social care research
- Range of studies size, duration, approach
- Applications from range of organisations including 'user controlled' organisations

- Deadline for outlines Thurs 6th May
- Receive decision on outline proposal by mid August
- If shortlisted, submit full proposal by October
- Decision on funding to be made February 2011

Researcher-led calls

- Applicants can submit outline proposals at any time during the year, with three cut-off dates when applications will be considered by the Programme Advisory Board.
- The next cut-off date to submit outline proposals is 10 May 2010 by 1pm.
